FAMILY Golf*: Families with the head of household age 40 and above. Entitles all members of the immediate family (children under age 23) to all privileges, facilities and programs of the Club.

Annual dues: \$2,310.00 Monthly Food Minimum: \$45

Semi-annual: \$1,270.50

Monthly: \$221.38

JUNIOR FAMILY Golf*: Families with the head of household age 39 and under. Entitles all members of the immediate family to all privileges, facilities and programs of the club.

Annual dues: \$1,842.50 Monthly Food Minimum: \$45

Semi-annual: \$1,013.38

Monthly: \$176.57

SINGLE Golf: Unmarried adult age 40 and above. Entitles the member to all privileges, facilities and programs of the Club.

Annual dues: \$1,705.00 SINGLE Monthly Food Minimum: \$30

Semi-annual: \$937.75

Monthly: \$163.40

JUNIOR SINGLE Golf: Unmarried adult age 39 and under. Entitles the member to all privileges, facilities and programs of the Club.

Annual dues: \$1,375.00 Monthly Food Minimum: \$30

Semi-annual: \$756.25

Monthly: \$131.77

SOCIAL: Families or single persons. Entitles all members of the immediate family to all privileges, facilities and programs of the Club, with the exception of golf. Three complimentary rounds of golf are provided annually (cart not included) and may be split among the family members.

Annual dues: \$825.00* Monthly Food Minimum: \$45 for family/\$30 single

2 consecutive monthly payments: \$412.50

OUT of AREA SOCIAL: A special type of social membership for people whose residence is generally outside of McLean County, as determined by the Board of Directors. \$264 annually
